# Terms & Conditions - Rules & Regulations

## **General Provisions:**

The participant in the show formally undertakes to comply with these RULES and to comply in all respects with the applicable regulations in the scope of its participation to the show.

It undertakes furthermore to take note of and to accept without reservation the instructions laid down by the Management of the exhibition and conference generally, whose dress or behavior could interfere with the image of the show, its serenity or decorum.

More generally, each Participant hereby guarantees that its offer of products and / or services does not contravene public order and the applicable regulations. Notably, each Participant acknowledges that it is strictly forbidden to exhibit products and/or services that is illicit or result from illicit activities and that it is also strictly forbidden to non authorized parties to propose products and/or services which result from regulated activities. In this respect, in case of infringement of the applicable regulations, participants may face legal proceedings, without prejudice to any measures that the Organizer reserve to take in order to put an end to the trouble

## **Organizer's Obligations and Rights:**

The Organizer undertakes to ensure that the show is properly conducted in Amman - Jordan on the dates and time indicated in this contract.

The dates may however be changed by the Organizer, in addition to an unforeseen circumstance or Force Majeure, without the participant being able to object to this or to claim any compensation, if it was in the interest itself of the show, in view of its purpose and its international character, that such a change should take place, with the Organizer being responsible for notifying the Participant of such in writing as soon as possible in the light of the circumstances.

Failing this, the Organizer may cancel the show outright after notifying the Participant of such; in this case, the participation contract with or without letting of stands will be terminated as of right.

The sums still available from the amount of the participations, after paying all the expenses incurred by the Organizer, will be divided among the Participants pro rata to the sums paid by them, without them being able to bring any proceedings on any count and for any reason whatsoever against the Organizer, which each Participant expressly agrees to, this being an essential and determinant condition of its adhesion to this participation contract with or without letting of stand.

The Organizer is exempt from any liability for any or loss, damage, injury, costs and expenses generally (including interference with possession or quiet enjoyment and any commercial harm or loss) that might be suffered by the participants for any reason whatsoever.

## **Health & Safety Regulations – Order and Policing:**

The Participant is obliged to take note of and to comply with the health and safety regulations measures laid down by the Public Authorities or by the management of the venue, or that may be adopted by the Organizer.

The Participant is likewise obliged scrupulously to comply with the internal order measures inside the event or any policing measures prescribed not only by the Organizer, but also by any competent authority.

**Participant's Obligations and Rights:**

Application for space at the Exhibition shall be made on the form overleaf and shall be duly signed by the Exhibitor or a person authorized by him. Following receipt of the application together with initial payment, the Organizers reserve the right to refuse any application at their absolute discretion without necessarily giving the reasons for such refusal.

This participation contract is final and irrevocable. In the case of withdrawal at any time whatsoever and for any reason whatsoever, except in the case of Force Majeure, the signatory to this participation contract will remain liable for the full amount of its participation and for any invoice relating thereto; in the case of Force Majeure, however, all payments it will have made and received by the Organizer will be returned to the Participant.

In addition to the space price, (and stand fitting service when applicable), Exhibitors will be billed for optional services requested; such as rented furniture, power supply, telephone lines, show catalogue advertisements and other.

An Exhibitor who fails to exhibit for any reason without having been released from the agreement by the Organizers shall be liable for the full amount of the contract plus additional amounts incurred by the Organizers.

In the show an Exhibitor declares bankruptcy or the exhibitor is in receivership and is being liquidated, the contract with such an exhibitor shall be cancelled and any amount already paid shall be retained by the Organizers.

The Organizers shall not in any show be held responsible for any restrictions or conditions which prevent the construction, erection, completion, alteration or dismantling of stands or the entry, placement or removal of exhibits or for the failure of any service or amenities provided by the hall landlords or other third parties.

**Payments Policy:**

At any time the exhibitor may request a reduction of exhibit space, however, this may require a reassignment of booth location. Exhibit space reduction does not guarantee a refund. All reductions will follow the same rules for original exhibit space as cancellations listed below.

The payment schedule for space only, shell stand or furnished stand is as follows:

- 50% with submission of Application
- 50% by date specified on the Application (due to 1 month prior to the show opening dates)

Where the application is made after the final payment date specified on the application, the total shall be payable with the Application. The total price represents only the payment for the space, details of which are set out overleaf. All other goods and services required by the Exhibitor shall be paid by the Exhibitor in addition thereto. Exhibitors will not be allowed to take over their space or stands if the payment terms specified on the Application are not honored.

**Cancellation Policy:**

In the show the Organizers agree to a cancellation of the space contract, the Exhibitor will be liable for all, or part of the contract price depending on when the cancellation request was received and acknowledged:

The date of the cancellation request is the one on which the Organizers receive written notice by courier or fax, and acknowledge receipt of same to the Exhibitor. In addition to the cancellation charges, the Exhibitor will be liable for any specific consequent amount incurred on the Exhibitor's behalf by the Organizers. These terms cannot be varied under any circumstances.

This participation contract is final and irrevocable. In the case of withdrawal at any time whatsoever and for any reason whatsoever, except in the case of Force Majeure, the signatory to this participation contract will remain liable for the full amount of its participation and for any invoice relating thereto; in the case of Force Majeure, however, all payments it will have made and received by the Organizer will be returned to the Participant.
